Financial Report:

\$18,675 is the latest GIA payment received with \$10,000 unbilled so far; FVSAS also received 2 checks: \$1,000 from Rotary and \$100.08 from Ho'okupa'a as reimbursement for hotel. The recent NMTC phone call addressed that FVSAS would need a minimum of 5 million for project:

FVSAS may not have funds to meet the NMTC thresholds. FVSAS would need to come up with an amount before NMTC comes in with money.

Ho'okupa'a Update:

Lisa Canale was unexpected absent so this is tabled.

Needs Assessment Finalization:

Lynn Morrison's staff did literature review with a look at studies including how green schools improve school performance. Lynn Morrison's team submitted bills with an April date. Lynn Morrison will email the final report to the FVSAS Board.

Planning the Master Plan Focus group/Community Meeting 6/23/16:

"What does community want for their community school?" will be the focus. The Community Meeting will not be a question answer session. There will be a "parking lot" poster for questions on post-its. A parent will take lead on parent focus group; staff and faculty may be contacted with questions in place of a staff/faculty focus group. The parent meeting may be in July because advertisement is needed and it will be held in Volcano and in Kau. The Community Meeting will be next week June 23, 2016 5:30 at KKL second floor. The Community Meeting was advertised in the VCA Newsletter and will go up on Friends website (Mara Saltzman to put on the FVSAS website). Mailings to parents could be used in place of meeting.

Old Volcano Road (OVR) Consolidation:
